CANCELLATION REQUESTS

Requests for cancellation within 90 days of departure must be made in writing. Each tour is priced as a package and no refund or discount will be made for any part of the tour/activity in which you choose not to participate. In addition, no refunds will be made if you leave the trip voluntarily or for cause after the date of departure. Participants may also be subject to any cancellation fees assessed by the purveyors of services, including hotels. Note that onboard ship credit for *Oceania* Cruises can only be used on *Marina* during the duration of the participating cruise. It is not refundable in the case of trip cancellation.

TRIP INSURANCE
